This Agreement is entered into between **Iberian Athletic Club** (the “Club,” “we,” “us”) and the parent or legal guardian identified below (“Parent/Guardian,” “you”) on behalf of the participating minor or adult player (“Player”). Please read it carefully. By signing, you agree to all terms, including the **Assumption of Risk and Release of Liability** in Sections 7–8.

2. Program Overview

The Club offers a soccer training program open to players of all ages. The program runs from **August through May (10 months)**. Players are placed into one of two groups by age and level. Enrollment is ongoing and players may register at any time during the season.

- **Training:** 3 days per week (schedule varies by age group).
- **Session Length:** 1.5 hours per session.
- **League:** Players may compete in a league for an additional, separately billed cost.
- **Location:** 10700 SW 56th St, Miami, FL 33165 (hosted at BridgePrep Academy South). Enrollment at BridgePrep Academy South is **not** required to participate.

The Club may reasonably adjust schedules, groupings, coaching staff, and locations. We will provide notice of material changes when practicable.

3. Fees & Payment

The program runs from August through May (10 months). The following fees apply; all amounts are in U.S. dollars.

Registration Fee	\$150 (one-time)	Due at enrollment. Includes practice + playing uniforms.
Monthly Tuition	\$150 / month	10 months (Aug–May). Due on the 1st.
Pay in Full	\$1,500	Full season — 10% discount (save \$150).
League Play	Separate cost	Billed separately, if applicable.

Payment Option — select one:

- ☐ **Pay in Full** — \$1,500 for the full season (10% discount, a \$150 savings). Due in full at time of enrollment.
- ☐ **Monthly** — \$150 per month, due on the 1st of each month, August through May (10 payments).

- **Registration Fee.** A one-time \$150 registration fee is due at the time of enrollment and is non-refundable. It includes one set of practice and playing uniforms; replacement uniforms may be purchased separately.
- **Monthly Due Date.** For the monthly option, tuition of \$150 is due on the 1st of each month, August through May. A late fee of \$50 applies to any payment not received by its due date.
- **Mid-Month Enrollment.** A Player who enrolls after the start of a month pays a prorated amount for that first month (based on the remaining sessions in the month), together with the \$150 registration fee, at the time of enrollment. Regular billing then begins on the 1st of the following month.
- **Season Commitment.** By enrolling, you commit to the Player's participation for the full August–May season and to the tuition for that commitment, regardless of attendance or partial-month participation.
- **Withdrawal & No-Refund Policy.** Enrollment is a commitment for the full August–May season, and all fees are non-refundable — including the registration fee, any monthly tuition paid, and the pay-in-full amount. Discontinuing attendance does not cancel the season commitment or any remaining balance owed for the season. The sole exception is a release for a valid medical reason: the Club's administration may, in its sole discretion and on a case-by-case basis, release a Player from the remainder of the season upon a written request supported by appropriate medical documentation. No release is effective unless approved by the Club in writing, and the approval of any one request does not obligate the Club to approve any other.
- **Late & Returned Payments.** A fee of \$50 applies to any late payment or any returned or declined payment.

Initial here: _____ I understand the program is a full-season (August–May) commitment and that all fees are non-refundable, subject only to a medical release approved by the Club in writing.

4. Uniforms & Equipment

The registration fee includes practice and playing uniforms. Players are expected to wear the Club uniform to sessions and matches and to arrive with appropriate footwear, shin guards, and a water bottle. Players are responsible for their personal belongings; the Club is not liable for lost, stolen, or damaged personal property.

5. Attendance, Schedule & Conduct

- Players should arrive on time and be picked up promptly after each session. Parents/Guardians are responsible for supervision before and after scheduled activities.
- The Club may cancel or reschedule sessions due to weather, facility availability, or other circumstances. Missed sessions are not generally refundable or credited.
- Players and Parents/Guardians agree to treat coaches, staff, officials, teammates, and opponents with respect. The Club may suspend or dismiss any participant for conduct that is unsafe, disruptive, or contrary to the spirit of the program, without refund.

6. Medical Authorization & Emergency Treatment

I certify that the Player is physically able to participate in soccer training and competition. In the event of injury or illness, I authorize the Club's coaches and staff to obtain or administer first aid and, if I cannot be reached, to secure emergency medical care for the Player. I accept financial responsibility for any medical treatment provided and understand the Club does not provide medical or accident insurance for participants.

7. Assumption of Risk

I understand that participation in soccer and related athletic activities involves inherent and other risks of **physical injury, including serious injury, permanent disability, and death**, and damage to property. These risks include, without limitation, contact with other players or equipment; falls; collisions; overexertion; muscle, bone, and joint injuries; heat- or weather-related conditions; transportation to and from activities; and the actions or negligence of others. Knowing these risks, I **voluntarily and knowingly assume all such risks** for myself and on behalf of the Player.

8. Release & Waiver of Liability; Indemnification

In consideration of the Player being permitted to participate in the Club's soccer program, I, on behalf of myself, the Player, and our respective heirs, executors, administrators, and assigns, agree as follows:

- **Release.** I release, waive, and discharge Iberian Athletic Club and its owners, directors, officers, coaches, staff, volunteers, and agents, and the facility owner/host (collectively, the "Released Parties"), from any and all claims, demands, damages, and causes of action arising out of or related to the Player's participation, **including claims based on the ordinary negligence of the Released Parties**, to the fullest extent permitted by law.
- **Indemnification.** I agree to indemnify and hold harmless the Released Parties from any loss, liability, or cost, including reasonable attorneys' fees, arising from the Player's participation or from any claim I or the Player may bring that is released above.

This release does not apply to gross negligence or willful or wanton misconduct, and is intended to be as broad and inclusive as permitted by the laws of the State of Florida. If any portion is held invalid, the remainder shall continue in full force and effect.

9. Photo & Media Release

I grant the Club permission to photograph and record the Player during Club activities and to use such images and recordings for promotional, marketing, and social-media purposes without compensation. If you do **not** consent, initial here: _____.

10. Communications Consent

I consent to receive program-related communications from the Club by phone, text message, and email at the contact information provided above. I may opt out of non-essential messages at any time.

11. Governing Law & Entire Agreement

This Agreement is governed by the laws of the State of Florida, and any dispute shall be venued in Miami-Dade County, Florida. This Agreement constitutes the entire agreement between the parties regarding the program and supersedes any prior understandings. It may be amended only in writing.

12. Acknowledgment & Signature

I HAVE READ THIS AGREEMENT AND THE RELEASE OF LIABILITY. I UNDERSTAND ITS TERMS, INCLUDING THAT I AM GIVING UP SUBSTANTIAL RIGHTS, AND I SIGN IT FREELY AND VOLUNTARILY.
